ARTWORK AT HOME National Artwork Competition - Terms and Conditions

1. The Longton Property Group proudly hosts a national artwork competition with a theme of creative artwork and decoration pieces for contemporary Australian apartments during the period stipulated on the application form ("Competition").
2. This Competition is open to all art students currently enrolled in an arts degree at university, college, TAFE or any other arts institution located in Australia, between the age of 17 and 30 years. Employees of Longton Property Group or any person associated with this Competition and their immediate families are not eligible to enter.
3. Persons aged under 18 years are eligible to participate in this Competition, an adult parent or guardian must enter this Competition on behalf of the participant. By entering this Competition, the adult parent or guardian (as applicable) agrees to the terms and conditions of this Competition and gives permission for their child to participate in this Competition. The adult parent or guardian also authorises the Longton Property Group to display the participant's entry in this Competition, and to use, reproduce and publish the entry at any time for publicity and marketing purposes through internal and external publications of the Longton Property Group and any medium, for example, radio, television, video or internet. The adult parent or guardian agrees that the Longton Property Group accepts no responsibility whatsoever for the use and reproduction of such materials by third parties otherwise than as intended above.
4. This Competition is open to any form of artwork, excluding derogatory, obscene and pornographic art and video and installation art. The mediums include but are not limited to paintings, drawings, sculptures and photographs. All entries should be accompanied by a brief synopsis of no more than 500 words.
5. This Competition commences at 9am on 1 March 2013 and closes at 5pm on 30 September 2013.
6. Longton Property Group offers the following three prizes to the winners.
 - One Grand Prize: \$3,000;
 - Two Second Prizes: \$1,000 each; and
 - Three Third Prizes: \$500 each.
7. The awards will be announced on 23 October 2013.
8. Dimension restriction applies to all the artwork submitted.
 - Two dimensional pieces up to 4m (width) x 2m (height)
 - Three dimensional pieces up to 2m (height) x 1.5m (width) x 1m (depth)
9. The judging panel will select the winning artwork based on the following criteria:
 - How well the piece relates to the theme
 - Aesthetic and artistic appeal
 - Creativity
 - Originality
10. If the judging panel considers that there is no entry of sufficient high merit, no prize will be awarded or, alternatively, the judging panel has a discretion to award a Second Prize or a Third Prize only. Whether all the prizes on offer are awarded and the type of prizes awarded shall be at the discretion of the judging panel.

11. The decisions of the judging panel and the Longton Property Group on the interpretation of all terms and conditions of this Competition shall be final and legally binding, and no correspondence will be entered into with regard to the judging panel's decision.

13. Entrants:

- a. are responsible for paying the costs of transporting the artwork to and from the Longton Property Group, including the cost of transporting the artwork once it is returned to the entrant. Neither the Longton Property Group, nor any of its affiliates, directors, officers or employees, nor any third party vendor retained by the Longton Property Group will be liable or have any responsibility of any kind for any loss or damage that may incur in the event of any transportation or storage of the entrants' works; and
- b. must make arrangements to pick up his or her Artwork from Longton Property Group at his or her own risk and expense. If the entrant does not arrange for the pick up of his or her Artwork within 20 working days from 14 October 2013, the Artwork becomes the property of the Longton Property Group, unless otherwise agreed by the parties in writing.

a) Each individual who contributes to a group entry is deemed to have consented to entering this Competition and to have accepted the terms and conditions of this Competition.

b) All entrants agree to provide the Longton Property Group with proof of identity, residency, age and/or proof of entry validity if reasonably requested by the Promoter. Proof of age, identification, residency and entry considered suitable for verification is at the sole discretion of the Promoter. 15. Multiple entries are allowed in this Competition.

16. The entrant represents and warrants that the artwork is the entrant's sole original work and possesses unencumbered title to the artwork. The entrant indemnifies the Longton Property Group for any breach of copyright or intellectual property against other person, given that the Longton Property Group will be using images of the artwork for promotion purposes.

17. Entrants consent to any infringements of their moral rights by the Longton Property Group in connection with this Competition. Entrants consent to the Longton Property Group using their name, biographical details and likeness in connection with this Competition.

a) Entrants agree to, at the Longton Property Group request, participate in reasonable promotional activity surrounding this Competition or the winning of any prize, free of charge, and they consent to the Longton Property Group and its related bodies corporate using their name and image in any promotional material. Without limitation, entrants consent to being broadcast, filmed, photographed or otherwise recorded without compensation while participating in this competition, or in taking or using any prize, and they consent to the Longton Property Group repeating any such broadcast, film or other recording at any time.

b) Entrants consent to the disclosure of their information (including their entry) to third parties and grant the Longton Property Group, its successors and affiliates, a free, non-exclusive, worldwide, sub-licensable, perpetual and irrevocable licence to use, reproduce, distribute, adapt, publish, broadcast communicate and perform their entry, in whole or in part for any purpose including this Competition.

c) The winners consent that their artwork, selected by the judging panel, will be displayed at the Longton Display Centre located at Unit 7, 7-9 Kent Road, Mascot NSW 2020 ("*Mascot Showroom*") or at the Longton Lifestyle Hub located at 413 George Street, Sydney NSW 2000 ("*George Street Showroom*"), Longton Head Office, Longton website, any social media platforms or other deemed suitable for the period of 30 days after the date of the awards being announced. The artwork may be moved to and displayed at either the Mascot Showroom or the George Street Showroom at any time and at the Longton Property Group's sole discretion.

18. The Longton Property Group reserves all rights with regards to this Competition. Upon request by Longton Property Group, the entrant, other than the winners, may give permission to Longton Property Group to use their artwork for future promotional activities or enter into a consignment agreement, which would permit Longton Property Group to display their artwork as stipulated in paragraph 17(c) and sell the entrants' artwork on their behalf.

While it is expected that the terms and conditions of this Competition will be strictly observed, the Longton Property Group reserves the right to waive compliance with or alter the terms and conditions of this Competition at any time.
